## Practitioners Must Recertify Their CMS EIDM User Accounts by June 30, 2016 for Continued Access

The CMS Enterprise Portal in July 2015 transitioned to the Enterprise Identity Management (EIDM) system for use in idenfication of verified users. The new EIDM system includes Identity Verification, Access Management, Authorization Assistance Workflow Tools, and Identity Lifecycle Management functions.

However, those who use EIDM as identity proofing must recertify their accounts annually to continue access to these functions. The EIDM Security Official (SO) or Individual Practitioner must recertify by Thursday, June 30, 2016.

The SO and Individual Practitioners can recertify by logging into the <a href="CMS Enterprise">CMS Enterprise</a>
<a href="Portal">Portal</a>
using existing EIDM credentials to access the list of users who require recertification. SOs and Individual Practitioner can locate the list of users by navigating to the View and Manage My Access page after logging in and selecting the Annual Certification link on the left pane. The SO and Individual Practitioner can recertify multiple users at one time.

If you experience issues trying to recertify users, please call the QualityNet Help Desk immediately at 1-866-288-8912. The QualityNet Help Desk hours of operations are Monday - Friday, 7 a.m. to 7 p.m., Central Time.

Take action today. The deadline for SOs and Individual Practitioners to recertify user roles is June 30th. Current certification will expire after that date and user roles will be revoked. If that happens, users must go through the process of requesting the role for SO and Individual Practitioner approval.

## Bureau of Narcotic Enforcement (BNE) Releases Waiver Process for Practitioners Prescribing 25 Prescriptions or Less

The Bureau of Narcotic Enforcement (BNE) has released the forms and an FAQ for practitioners who want to certify that they will not issue more than twenty-five prescriptions during a twelve-month period. Practitioners submitting a certification will not be required to issue prescriptions electronically. Prescriptions in both oral and written form for both controlled and non-controlled substances must be included in determining whether the practitioner will reach the limit of twenty-five prescriptions.

The practitioner can either submit a certification online through the <u>Electronic</u> <u>Prescribing Waiver (EPW) application on the NYS Health Commerce System (login required)</u> or by submitting a paper certification form to BNE at this address:

## Developing a Small, Independent Practice Response to Value Based Payment Models in New York City

The NY Chapter of the American College of Physicians, in collaboration with the NYS Academy of Family Physicians, the NYS American Academy of Pediatrics, NYC Population Health Improvement Program and the United Hospital Fund, recognizes the challenges independent and small practices face as payers move to Value Based Payment systems.

Value based payment models require primary care practices to meet quality and performance improvement goals. Practices must have personnel (e.g. care managers and/or coordinators, IT support and /or data analytics staff, nutritionists or diabetes educators and behavioral health support) and capacities that small practices (typically defined as 15 or fewer clinicians) may not be able to afford alone. It also requires having (or assembling) a large enough population of patients to generate statistically meaningful results for performance incentives.

Regardless of the initiative, be it Medicaid's Delivery System Reform Incentive Program (DSRIP), State Innovations Model (SIM)/Advanced Primary Care (APC), Transforming Clinical Practice Initiative (TCPI), Medicare's Merit-based Incentive Payment System (MIPS), Medicare Access and CHIP Reauthorization Act (MACRA), or the CMS Comprehensive Primary Care Plus (CPC+), you are being asked to "transform" in order to be eligible for higher reimbursement.

One way for small, independent practices to remain independent may be to share capacities and personnel across a number of practices.

The NY Chapter of the American College of Physicians is coordinating five small focus groups in New York City to:

- 1. Understand which functions would be desired as a "shared service" function
- 2. Explore key preferences in the design and delivery of shared service arrangements, including:
  - The suite of services you would considerhelpful and amenable to sharing
  - Key considerations for grouping of practices
- 3. Consideration of options for selection of a host organization to house/provide those services to be shared.

# Letter from the CDC Advisory Committee on Immunization Practices (ACIP) Regarding Flu Vaccines

**Dear Health Care Provider:** 

As you plan for the upcoming 2016-2017 influenza season, be aware of the recent interim recommendations of the Centers for Disease Control and Prevention (CDC) Advisory Committee on Immunization Practices (ACIP) regarding the use of FluMist® Quadrivalent..

At the June 22 meeting of the ACIP, preliminary data were shared regarding the effectiveness of FluMist® Quadrivalent during the 2015-2016 influenza season. Based on a review of these data, the ACIP issued an interim recommendation that FluMist Quadrivalent should not be used in any setting for the 2016-2017 influenza season. This decision was based on CDC vaccine effectiveness study results from the last three influenza seasons, in which FluMist Quadrivalent did not demonstrate statistically significant effectiveness in children 2-17 years of age in the US.

Results are currently available from five observational vaccine effectiveness studies involving live attenuated (LAIV) and inactivated (IIV) influenza vaccines in children 2 to 17 years of age during 2015-2016, and can be viewed here.

Influenza vaccine effectiveness varies from season to season based on differences in circulating influenza strains and strains contained in the vaccines. The observed effectiveness of FluMist Quadrivalent in 2015-16 was driven by low to moderate effectiveness against circulating A/H1N1pdm09 influenza viruses, which was also observed in 2010-11 and 2013-14. Against other influenza viruses, FluMist® effectiveness in US children has ranged from 46% to 82% against vaccine-similar A/H3N2 and B viruses in 2010-11, 2011-12, 2012-13, 2013-14, and 2014-15 influenza seasons.
