#### Governor Andrew Cuomo Releases 2016-2017 Proposed Budget

#### Highlights of Health-Related Issues



Governor Cuomo released his proposed \$143.6 billion budget for the upcoming State fiscal year beginning April 1, 2016 through March 31, 2017. While there were significant proposals to stimulate the economy and strengthen the State's infrastructure, there were several proposals that will have an impact on healthcare and physician practices if enacted. The Legislature will now hold public hearings on the various elements of the budget, and will then negotiate with the Governor in the hopes of passing a final budget before April 1. The Governor proposed a \$15 minimum wage for all workers, and an expansion of vital infrastructures to include both new building of mass transit capacity and re-building of roads and bridges. In healthcare, the following proposals

will be closely monitored as the hearings and negotiations get underway:

- Reductions in the medical liability excess pool that provides the "second layer" of coverage. The
  proposed changes would favor high risk specialties and territories which may leave many physicians
  without this needed coverage
- Limited Service (or Retail) Health Clinics would be allowed to provide a list of limited services and be responsible for adhering to new accountability requirements similar to those of Diagnostic and Treatment and Community Health Centers.
- Changes to the Workers' Compensation Law to expand eligible providers, change certification procedures and make improvements to the hearing process for these cases
- Eliminates existing prescriber prevails rules under the Medicaid program except for certain psychiatric drugs
- Continues funding for Doctors Across New York and proposes a separate category of funding for mental health providers which would supplement the spots for other shortage specialties.

The extensive budget documents have many other provisions, and we will continue to highlight these in upcoming issues of Your Chapter in Action as discussions and the Legislative sessions continue.

### Advocates Attend Celebration of Adoption of the Mandatory Meningitis Vaccination Law

sponsors of the legislation, Senator Kemp Hannon (R-6) and Assemblywoman Aileen Gunther (D-100), in celebration of the public health success. *(pictured on right)* 

Stories of lost loved ones and survivors were shared amongst all who worked so hard to get the legislation passed and ultimately signed by the Governor. Personal tragedy was turned into hope for the future as speaker after speaker

expressed gratitude for the strength of the coalition against significant odds. The

Chapter had been active in this campaign, and was represented in Albany by Brianne Navetta, MD and Chapter Executive Director Linda Lambert. The passage of this bill serves as a model for advocacy action by physicians, as again and again the power of having Brianne ("the Doctor") at the Capital speaking at meetings on the clinical issues related to caring for patients and the value of the vaccine was emphasized.

### **Practice Management**

#### Patient Registration For Medical Marijuana Begins



The State Department of Health on Wednesday, January 6, unveiled an <u>online registration system</u> for patients seeking to qualify for the state's medical marijuana program. The program is due to become active later this month, though Governor Andrew Cuomo has signed legislation in 2015 creating an expedited system.

Before patients can register online, they must first be certified by a physician who has been authorized to operate in the medical marijuana program. Doctors must have taken an online course and registered with the state in order to prescribe medical marijuana.

After online registration is completed, patients will then receive a registry identification card in the mail, which must be shown when purchasing medical marijuana at a dispensing facility. New York's medical marijuana program is limited to a small number of illnesses, including cancer, HIV/AIDS, ALS, Parkinson's as well as severe epilepsy, among others. The medical marijuana program includes five companies growing, manufacturing and dispensing prescription medical marijuana in the state. It's expected that given the small patient pool, registration for the program will be relatively small in the beginning.
