Primary Care Medicaid Rate Increase Retroactive Payments Now Available

Fee for service payment of the Primary Care rate increase for Medicaid began within payment cycle 1872 (7/4/13). Fee for service **RETROACTIVE** payment of the increase will begin with payment cycle 1892 (11/21/13). eMedNY will reprocess fee for service claims for dates of service on and after 1/1/13 at the increased rate to providers who submitted complete attestations. NYS Health Department Conducts Statewide Stakeholder Meetings on the New Hep C Testing Law

The new State requirement to offer a Hep C screening test to every individual born between 1945 and 1965 goes into effect 1/1/14. The State will convene stakeholder meetings to collect information, input and comment about implementation. All meetings will be held from 10 am – noon:

<u>New AHRQ Toolkit: Improving Your</u> <u>Office Testing Process</u>

Approximately 40% of primary care office visits involve some type of diagnostic medical test. Sometimes, tests are lost, overlooked, incorrect or incomplete. It is estimated that nearly a quarter of all medical errors in ambulatory care settings are due to inadequate follow-up of abnormal test results. Go to:
