continue to use the CMS <u>provider-specific fact sheets</u> for information about COVID-19 Public Health Emergency (PHE) waivers and flexibilities.

Although the New York State Department of Health allowed masking requirements in healthcare facilities to expire on February 12, I personally recommend wearing masks in crowded places, including healthcare facilities. The masking requirements due to the pandemic were put into place by the state and the CDC. In a recent advisory letter, acting NYS Health Commissioner James V. McDonald, MD said that the decision not to request a renewal of the emergency regulations was due in part to the decreasing levels of COVID-19 infections. This week, the Advisory Committee on Immunization Practices (ACIP) released the recommended <u>Immunization Schedule</u> for Adults Aged 19 Years or Older. The COVID-19 vaccine row is a new addition to the tables.

Designed for physicians and other healthcare leaders, the <u>HANYS Quality Residency Program</u> helps strengthen quality improvement processes through in-depth training of quality and patient safety fundamentals. The Course registration closes on March 14th.

Continuing the saga of major mergers and acquisitions, earlier this month CVS Health and Oak Street Health entered into a definitive agreement under which CVS Health will acquire Oak Street Health in an all-cash transaction representing an enterprise value of approximately \$10.6 billion. Oak Street Health touts themselves as a leading multi-payor, value-based primary care company helping older adults stay healthy, employs approximately 600 primary care providers, and has 169 medical centers across 21 states. Late last year, CVS Health acquired home-based care company Signify Health in a deal valued at \$8 billion. The Oak Street health deal is CVS Health's second largest purchase in recent years, having acquired Aetna in 2018 for \$70 billion.

The NYACP/BU CME PAIN MANAGEMENT COURSE has been updated and WAS launched today - February 16, 2023!

The 3-year renewal for prescribers who took the first training course in 2017 must renew again by July 1, 2023. The course is also available to all NYS licensed prescribers, and this course fulfills NY's mandated 3-hours of CME training in addiction and pain management for prescribers as required by NY Public Health Law Sec. 3309-A(3).

What You Need to Know

- **Target Audience:** Physicians, nurse practitioners, residents, registered nurses, nurses, physician assistants, dentists, and pharmacists.
- **CME/MOC:** The NYACP/BU educational activity will offer participants 3 Hours of *AMA PRA Category 1 Credits™* in addition to 3 MOC Points through the American Board of Internal Medicine's (ABIM) Maintenance of Certification (MOC) program.
- Licensed prescribers in NY are mandated to complete 3 hours of training every 3 years.
- Newly licensed prescribers are mandated to complete training <u>within 1 year</u> of receipt of your license and every three years thereafter.
- For Residents prescribing under a hospital or facility DEA number:
 - Residents must complete the course <u>within 1 year</u> of the start of their residency and every 3 years thereafter
 - Hospitals must attest that ALL residents prescribing under their institutional DEA number have completed the required training
- The course is \$25.00.

- A group payment option is available for new residents and/or other institutional prescribers.
- To be in compliance, prescribers must file the self attestation after completing the course.

NYACP Advocacy Intern Nisha Khubchandani

Nisha Khubchandani is a fourth-year medical student at Albany Medical Center (AMC), pursuing both a MD from AMC and an MPH from the State University at Albany.



Nisha's project as an Advocacy Intern entails implementing a screening protocol that will help identify patients at Albany Medical Center who are experiencing food insecurity. Food deserts are prevalent in over half of the counties in New York state, including Albany County. Research shows worsening disparities in food access between communities of color and communities with more white counterparts within the city of Albany. Given that access to food is a major social determinant of health, it is vital that clinicians collect data on which patients are impacted by a lack of healthy food. Such data will help clinicians direct patients to the most appropriate resources and community-based organizations.

Nisha is currently conducting research on validated screening protocols relating to food insecurity. If anyone has experience with a similar screening process and is willing to share any resources/advice, please contact Nisha at khubchn@amc.edu. Thank you in advance!

Advocacy Intern Shared His Experience Shane Solger, MD

After reading through my initial paper on what I had hoped to achieve from the Advocacy Internship experience, I was pleasantly surprised to see that it had fulfilled my expectations.



It was an important month in terms of networking for my immediate goal of bringing Haitian Creole interpreters to my hospital. The Advocacy Internship provided me with an audience with Johanne Morne, the New York Department of Health's Deputy Commissioner for Health Equity and Human Rights, who seemed incredulous when I described my hospitals' issue with interpretation services. It also provided me with the time and the tools to request an appointment with my state Assemblymember to try to push the issue from the state level. One of the more valuable experiences was connecting with Dr. Eileen Barrett, Chair-elect of the Board of Regents, whom I spoke with regarding her struggle and success as it pertained to bringing interpreters into the hospital. Her victory in New Mexico made it seem more practical here in Brooklyn, and she walked me through the many ways she tried to change the culture of her hospital to make it more accepting of in-person interpreters. I have begun to work on implementing much of what she had suggested within my program with similarly-minded faculty members.

The Committee of Interns and Residents/SEIU and the Committee on Political Education had initially been the avenue outside the standard hierarchy of the hospital administration I had gone through to advocate for myself, my patients, and my co-residents. However, direct involvement with the New York Chapter American College of Physicians (NYACP) over the last month has been enlightening. It has shown itself to be an organization that can be used for the same purpose. In addition, it was refreshing to see how another large organization could advocate for itself via its interactions with legislators, which was made tangible with the parting award NYACP gifted to Richard Gottfried. Finally, it was helpful to watch Dr. King discuss how she had created her legislative agenda and how she had hoped to sell it and talk about it with her legislators.

By observing the Senate and Assembly lists on StateWatch, it was very educational to see that more than two dozen health policy bills are introduced each week. These were in addition to the bills introduced regarding finance, commerce, the aging committee, education, etc. It would be unrealistic to expect each of these legislators to have a solid handle on everything they will vote on, especially if they do not have a medical background. This helped elucidate the importance of interacting with our elected officials to provide context to the bills they are expected to vote for through our senate and assembly.

Lastly, it was important for me to see how leaders in the internal medicine community engage with NYACP and advocacy. It provided a tangible example of how one might combine a career in advocacy with that of a clinician. While much of what I do now is via my resident union, fortunately, I will not be a resident forever. However, the problems plaguing physicians and patients regarding health equity and inefficiency are likely not going anywhere, so the tools and relationships I developed this last month are of utmost importance.

Interstate Medical Licensure Compact Bill Tuesday, February 28, 2023 / 7:00 - 8:00 pm / Zoom

Join us for an informational webinar presented by Humayun Chaudhry, DO, MACP, President/CEO of the Federation of State Medical Boards.

The Interstate Medical Licensure Compact (IMLC) is an expedited licensure application pathway created by the state medical boards that allows interested physicians who are already licensed in one state to instantly obtain licenses in

other states. To be eligible for the IMLC, which works like a TSA Pre-Check, a physician must meet the same nine criteria that have been agreed upon by all participating states and territories.

According to data from the Federation of State Medical Boards, 86% of the nation's physicians should be able to easily meet these nine criteria. Since the IMLC's introduction in 2015, as many as 38 states plus Guam and the District of Columbia have adopted it, enabling more than 53,000 medical licenses to be issued by state medical boards to interested and eligible physicians,

Humayun Chaudhry, DO, MACP enabling them to practice medicine or telemedicine across state lines. As with any other medical license, it is the state medical board that issues the license under the IMLC and which requires licensees to abide by that state's (or territory's) existing laws.
