UNICEF reports that the earthquake has affected around 1.2 million people, including 540,000 children, leaving approximately 2,000 people dead. This earthquake presents a significant crisis after the assassination of Haiti's president, Jovenel Moïse, in July. Many people have asked me what they can do to support the people of Haiti. ## New York COVID-19 Updates:

 All workers at New York hospitals, nursing homes, and adult care facilities must have received their first COVID-19 vaccination by September 27th



Third dose of vaccine authorized for certain patients

In an effort to raise vaccination rates among workers in New York hospitals and long-term care facilities, Governor Cuomo issued an order on August 16th requiring all staff to have received their first dose of a COVID-19 vaccine by September 27th. In this state, currently 75% of hospital employees, 74% of adult care facility workers, and 68% of nursing home workers are vaccinated. Limited medically-based exceptions to this new requirement apply.

The Governor also announced on August 16th that, following recent CDC guidelines, third doses of COVID-19 vaccinations will be approved in New York for moderately to severely immunocompromised individuals.

ACP Co-Signs Statement of Strong Medical Consensus for Vaccination of Pregnant Individuals Against COVID-19

ACP has co-signed a <u>statement</u> from leading medical organizations, strongly urging all pregnant individuals – along with recently pregnant, planning to become pregnant, lactating and other eligible individuals --

to be vaccinated against COVID-19. In light of rising cases as a result of the Delta variant, pregnant individuals are at increased risk of severe COVID-19 infection, including death and should protect themselves against potential harm from COVID-19 infection through vaccination.
