






President's Message: Dr. Jitendra Barmecha Progress Note:





With increasing violence in the workplace and post

pandemic challenges, the ABIM Foundation and the Beryl Institute want to learn more about individual experiences faced by internal medicine physicians when it comes to building trust within the health care delivery setting. Please share your thoughts and ideas on how

ACP is proud to join the <u>Healthcare Coalition for Firearm Injury Prevention</u>. ACP, along with other leading medical and leading public health care organizations across the United States, are coming together to push for a comprehensive public health approach to advance firearm injury prevention efforts through education, advocacy, and community-centered approaches to address this epidemic. <u>ACP's Annals of Internal Medicine</u> features free content about the effects of firearm violence and what internal medicine physicians can do to help.

Last week, WalletHub released its report on <u>2023's Best & Worst States for Doctors</u>. Unfortunately, New York is ranked as the 8th worst state to practice medicine. WalletHub compared the 50 states, and the District of Columbia, across 19 key metrics to identify the best states for those in the business of medicine. The data in NY calls for action from all the patient and physician advocates, so that communities being serviced by physicians will have a better ranking in all categories. The data set ranges from the average annual wage of physicians, to hospitals per capita, and the quality of the public hospital system.

Highlights from the report on Practicing in New York (1=Best, 25=Avg.):

• 51st – Hospitals per Capita

- 50th Annual Malpractice Liability Insurance Rate
- 47th Malpractice Award Payout Amount per Capita
- 47th Projected Physicians per Capita by 2030
- 46th Avg. Annual Wage of Physicians (Adjusted for Cost of Living)
- 46th Punitiveness of State Medical Board
- 28th Projected % of Population Aged 65 & Older by 2030
- 22nd Avg. Monthly Starting Salary of Physicians (Adjusted for Cost of Living)

The Final Rule of the 21st Century Cures Act mandates immediate electronic availability of test results to patients, likely empowering them to better manage their health. A new multisite survey study of attitudes and preferences revealed that nearly all participants surveyed supported immediate access to test results via an online patient portal, even if a healthcare provider had not yet reviewed the results. The <u>findings</u> were published in JAMA's Network Open.

NYSDOH Issues Blanket Waiver of the Electronic Prescribing Requirements

The New York State Department of Health (NYSDOH) has issued a letter granting blanket waivers to the requirement to issue electronic prescriptions when specific circumstances apply. The waivers took effect on March 25, 2023. The waivers primarily affect situations where electronic prescribing software limitations impede

entering valid patient instructions, although there are ten different, specific waiver types. You can read the <u>NYSDOH letter</u> granting blanket waivers to the requirement to issue electronic prescriptions when specific circumstances apply.

The NYACP/BU 3-Hour CME NYS Mandated Pain Management Course Updated Content and Launched in February 2023

Prescribers who took the training course in 2017 and 2020 must renew again by July 1, 2023. This online course is available to all NYS licensed prescribers and fulfills NY's mandated 3-hours of CME training in addiction palliative medicine, and pain management for prescribers as required by NY Public Health Law Sec. 3309-A(3).







What You Need to Know:

- **Target Audience:** Physicians, nurse practitioners, residents, registered nurses, nurses, physician assistants, dentists, and pharmacists.
- **CME/MOC:** The NYACP/BU educational activity offers participants 3 Hours of *AMA PRA Category 1 Credits™* in addition to 3 MOC Points through the American Board of Internal Medicine's (ABIM) Maintenance of Certification (MOC) program.
- Licensed prescribers in NY are mandated to complete 3 hours of training every 3 years.
- Newly licensed prescribers are mandated to complete training <u>within 1 year</u> of receipt of their license and every three years thereafter.
- For Residents prescribing under a hospital or facility DEA number:
 - Residents must complete the course <u>within 1 year</u> of the start of their residency and every 3 years thereafter.
 - Hospitals must attest that ALL residents prescribing under their institutional DEA number have completed the required training.
- The course is \$25.00
- A group payment option is available for new residents and/or other institutional prescribers.
- To be in compliance, prescribers must file the self attestation after completing the course.
