NYACP Supported MSSNY's March 2nd Lobby Day By Nicholas Cochran-Caggiano

NYACP is pleased to have supported the Medical Society of the State of NY's Annual Lobby Day on Tuesday, March 2nd. Kellin King, MD, FACP, Chair of Chapter's Health and Public Policy Committee, was featured at the virtual event along with other NYS Specialty Society physician leaders. Important policy issues impacting internal medicine covered at the event included items related to the NYS Budget:

- Oppose: Reforms allowing for the disclosure of complaints filed against physicians with OPMC prior to investigation and without proof of veracity
- Oppose: Reform of the Medical Liability Excess Program that would require physicians to cover 50% of the premium cost (currently the full premium is paid by the State)
- Oppose: Expanding the scope of practice for pharmacists to authorize them to order lab tests and counsel patients with certain comorbidities
- Oppose: Proposals for telehealth services that do not include payment parity and access for all New York licensed physicians

Assemblyman Richard Gottfried, Chair of the NYS Assembly Health Committee, presented remarks to lobby day attendees and participated in a Q&A session. Assem. Gottfried announced that there is a new Assembly Bill on telehealth that requires parity across platforms and telehealth providers to be licensed MD's in the State of NY. On the issue of pharmacy benefit manager's (PBM's), the Assemblyman agrees with a recent US Supreme Court decision relating to state rights to regulate PBM's under ERISA. Further, Gottfried noted that COVID has laid bare the problems in the medical system based on "the way we pay for health care" including delays in treatment, loss of medical insurance through employment, and difficulties in paying for basic care. The Assemblyman suggested that the NY Health Act (2019-2020 AB 5248-A/SB 3577-A) is a solution to address some of the significant disparities observed in our state. Although support is not universal, several physician specialties have expressed support for this bill.

Senator Rivera, Chair of the NYS Senate Committee on Health, also shared his feelings, focusing primarily on the budget PBM and telehealth items. Senator Rivera believes both issues should be considered independent from the budget and must be given their due consideration. He suggested that incorporation of such important health considerations into overall budget concerns diminishes the ability to adequately address these issues and to approach them in an appropriately nuanced manner. Senator Rivera also brought up the

"Invest in Our NY Act", a package of six state bills designed to tax the wealthy in NY and to raise more than \$50 billion in needed revenue.

With additional doses of COVID-19 vaccines arriving in New York State, now is the time to contact Governor Cuomo and Members of the New York State Assembly and Senate to communicate the importance of allowing community-based physicians, who have signed up to receive the vaccine through the NYS Immunization Information System (SYSIIS), to begin COVID-19 vaccine distribution to eligible patients.

Unfortunately, the current process of vaccine distribution is counterproductive. Physician offices are experiencing an increase in administrative workload but, even more importantly, patients throughout NYS are being negatively impacted. In many areas of New York, physicians are being forced to turn away their most vulnerable patient population including those being targeted for immediate immunization. Diverting patients to immunization sites that are not local and/or convenient needs to stop.
