National Immunization Conference 2024 Call for Abstracts

Abstract are now being accepted for the upcoming National Immunization Conference in Atlanta at the Marriott Marquis on August 12-14, 2024.
The 2024 NIC will bring together federal, state, and local public health partners to share the latest developments in science, program, policy, and communications on immunizations and vaccine-preventable diseases.

Submission deadline is April 19, 2024. Abstracts should fall within the following Themes:

- 1. Epidemiology and surveillance of vaccine-preventable diseases (including diseases for which vaccines are in the pipeline): Domestic and global (e.g. general epidemiology and surveillance, outbreaks and emergency response, role of laboratory in vaccination mission)
- 2. General vaccinology (e.g. vaccine effectiveness/impact, duration of protection, vaccine safety, vaccine immunology/vaccine design)
- **3. Vaccine equity & special populations** (e.g. community engagement, education, and partnership, maternal vaccination, partnerships/coalitions)
- **4. Implementation and program management** (e.g. covering the uninsured, immunization information systems [IIS] implementation, vaccine storage and handling, vaccine access and distribution, including transition to commercialization, data modernization, partnerships/coalitions)
- **5. Monitoring, assessment, and evaluation** (e.g. assessment methods, vaccination coverage, knowledge, attitudes and behaviors (KABs): providers, parents, public, economic analyses, forecasting,

partnerships/coalitions)

6. Strategies to improve vaccination coverage (e.g. quality improvement, vaccine confidence, adult vaccination, partnerships/coalitions, health and risk communication)

Weekly U.S. Influenza Surveillance Report (CDC FluView)



Key Points

- Seasonal influenza activity remains elevated but is decreasing nationally.
- Nationally, the number of weekly flu hospital admissions has been decreasing since January.
- Nationally, outpatient respiratory illness declined but remains above baseline.
- CDC estimates that there have been at least 31 million illnesses, 350,000

hospitalizations, and 22,000 deaths from flu so far this season.
