As part of her advocacy immersion, Uzo prepared a summary of Governor Cuomo's State of the State Address for NYACP Members.

State of the State Address:

Preparing for Post-COVID Reconstruction Era - by Uzoamaka Aniagba, MD

Governor Andrew Cuomo delivered his Annual State of the State address on Monday, January 11th. This year's address focused on how NYS will reimagine, rebuild and renew after one of the most tumultuous years in US History. The Governor addressed the state by stating "We are at War with the COVID pandemic" while standing in the ornate War Room located in the state's Capitol Building in Albany. He laid out his seven point plan overview on how NY will reconstruct and move forward in what is being called the Post-COVID Reconstruction Era.

I. DEFEAT COVID

Cuomo tackles COVID head on as the first point of business for the state. Cuomo hopes to do so by equipping hospitals with needed resources and tools to stay open and healthy. This is imperative because if hospitals in certain regions become overwhelmed and inundated with increased COVID cases, this could potentially lead to hospital closures and increased quarantine restrictions.

One major point raised during the address was the plan to reimagine the public health system because if COVID taught us anything, it was that our public health system needs reinforcing. Cuomo proposed to pass the Medical Supplies Act which will increase domestic manufacturing of PPE and medical supplies and decrease reliance on foreign imports from countries such as China. Additionally, Cuomo hopes to expand and foster new health technologies via telehealth, and emphasized that COVID has created innovation in patient care through electronic mediums.

ACP Advocacy in Action-2020 Achievements

2020 delivered unprecedented challenges, but ACP continued to advocate for internal medicine physicians, achieving policy change that improved daily practice and patient care.

Highlights

- Achieved Historic Payment Wins with CMS and Congress
 Wins include increased pay for office visit and other E/M codes that will result in an estimated 6% increase in total 2021 Medicare payments to internal medicine physicians.
- Supported Physicians and Patients during COVID-19
 Achieved financial assistance for practices; pay parity for telemedicine; Medicare regulatory requirements eased; increased funding for testing and treatment; and increased availability of PPE.
- Addressed Barriers to Care, Disparities, and Discrimination in Health Care
 Promoted diversity, equity and inclusion, releasing "Racism and Health in the United States" policy;
 participated in joint arguments to protect the ACA; and opposed rules to deny access to care.
- Policy Development Focus
 Addressed promoting prescription drug competition, step-therapy and nonmedical drug switching, and new surprise medical billing provisions; provided recommendations to the Biden transition team.
