New York DOH Weekly Influenza Report

The New York State Department of Health has provided its weekly update on influenza statistics:

During the week ending February 11, 2017:

- Influenza activity level was categorized as geographically widespread. This is the eighth consecutive week that widespread activity has been reported.
- There were 6,082 laboratory-confirmed influenza reports, a 14% increase over last week.
- Of the 2,265 specimens submitted to NYS WHO/NREVSS laboratories, 649 (28.65%) were positive for influenza.
- Of the 170 specimens tested at Wadsworth Center, 99 were positive for influenza. 4 were for influenza A (H1), 87 were for influenza A (H3), 6 were influenza B (Yamagata), and 2 were influenza B (Victoria)
- Reports of percent of patient visits for influenza-like illness (ILI3) from ILINet providers was 10.77%, which is above the regional baseline of 3.00%.
- The number of patients hospitalized with laboratory-confirmed influenza was 1065 a 13% increase over last week.
- There were no influenza-associated pediatric deaths reported this week. There have been five influenza-associated deaths this season.

Practice Management

Federal Judge Blocks Anthem-Cigna Merger

On February 8, in a significant win for patients, federal judge Amy Berman Jackson blocked the proposed Anthem-Cigna merger. The judge found that the merger would have

substantially lessened competition for the sale of health insurance to national employers resulting in higher prices and diminished prospects for innovation. Judge Jackson concluded that an enhanced ability to coerce physicians to accept lower reimbursement is not a merger efficiency defense. She determined that it would not benefit consumers and "would erode the relationship between insurers and providers" and "reduce the collaboration" that is essential to innovation in payment and delivery. As of February 13, Anthem has filed a notice of appeal to reverse Judge Jackson's







decision. Aetna and Humana also announced on February 14 that they will not appeal a judge's decision to block their merger on antitrust grounds.

CMS Final Rule on Medicare Part B Payment Policies: Find Out What's Changed

The Centers for Medicare and Medicaid Services (CMS) published in the Federal Register the CY 2017 Medicare Physician Fee Schedule Final Rule on November 15, 2016. This final rule updates payment policies, payment rates, and other provisions for services supplied under the Medicare



Physician Fee Schedule (PFS) on or after January 1, 2017. These include additional codes for chronic care management, prolonged services, and more. ACP's summary of the physician fee schedule rule includes the key Medicare policy changes that physicians should know for 2017.

CMS Extends Meaningful Use Attestation Deadline to March 13, 2017

CMS has extended the deadline to attest to meaningful use for the EHR Incentive Programs for 2016 performance until March 13, 2017. Clinicians must attest by the deadline to avoid a 2018 payment adjustment. To help providers prepare for the 2016 EHR Incentive Programs attestation period, CMS has released an attestation worksheet for eligible clinicians. Physicians can log their meaningful use measures for each objective in the worksheet and use it as a reference when attesting for the 2016 Medicare EHR Incentive Program in CMS' Registration and Attestation System.

If you are eligible to participate in both the Medicare and Medicaid EHR Incentive Programs, you MUST demonstrate meaningful use to avoid the negative payment adjustment. You may demonstrate meaningful use under either Medicare or Medicaid, depending on your patient mix.

Submit PQRS Reporting for 2016 Before It's Too Late!

The Physician Quality Reporting System (PQRS) is open for submission of quality reporting data for the 2016 performance period. Physicians must submit PQRS data on their 2016 performance to avoid receiving negative payment adjustments in 2018. Submission dates vary based on how physicians choose to report, so practices should check with submission vendors for deadlines. Additional details are available on ACP's PQRS page.

MLMIC Update on Transition to Berkshire Hathaway



MLMIC, NYACP's endorsed medical liability insurance provider, <u>announced in July</u> its intention to be acquired by

Berkshire Hathaway. The transaction is on track and progressing forward in accordance with the measures and actions required under New York State Insurance Law designed to protect the interests of the policyholders and the public. MLMIC had originally anticipated that the process would be completed by the third quarter of 2017, but now expect that process will be completed by year end 2017.

As such, policyholders can expect several major milestones to occur between now and the expected close of the transaction. The estimated timeline for these milestones is currently as follows:

- 1. In accordance with insurance law regulating such transitions, MLMIC is being examined by the NYS Department of Financial Services (DFS) to assess the financial condition of the Company. That examination is expected to be completed during the second quarter of 2017.
- 2. The DFS will also conduct an independent valuation of the Company to assess the fairness of the cash consideration to be paid by Berkshire to owners of eligible MLMIC policies from July 14, 2013 through July 14, 2016. This valuation is expected to be completed during the third quarter of 2017.
- 3. Once the examination and independent valuation are done, MLMIC's Board will request permission from the Superintendent to submit a Plan of Conversion for approval by DFS. MLMIC will then prepare and disseminate detailed information regarding the Plan of Conversion to all of those who are eligible to vote (i.e. those who were policyholders on July 14, 2016) on this transaction. The Superintendent will then hold a public hearing regarding the Plan of Conversion. Following this hearing, the Superintendent will review the Plan of Conversion, and if approved, will authorize MLMIC to conduct a vote.
- 4. A vote of those eligible to vote on this transaction is expected during the fourth quarter of 2017. If two-thirds or more of those voting elect to proceed with the transaction, the transaction will close and Berkshire will authorize distribution of payments shortly thereafter.

NYACP continues to work with the Medical Liability Mutual Insurance Company (MLMIC) on issues of importance to our members, and will continue to post updates as they become available.
