

Advocacy

NYACP Council/Board Meeting Convenes to Discuss Priorities, Committee Work, and Other Issues



On October 19, the NYACP Council/Board met in Queens to discuss and vote on resolutions and priorities for the upcoming year. The Council/Board discussed and approved several important topics. The 2019 Legislative Priorities which includes championing Access to Care, advocating for Quality of Care and Patient Safety, and a focus on Public Health were approved. Eight committees, including Education, Geriatrics, Early Career Physicians, and others, reported on their activities since the last meeting.

Resolutions were approved, calling for revisions to EMTALA (Emergency Medical Treatment and Labor Act), expansion of Telehealth, and expanding access to HIT, including protecting physicians from the cost of Electronic Health Record (EHR) enhancements and improving interoperability. The C/B also agreed on formal policies defining existing communications and membership plans, strategic plans and leadership development as required for the Chapter Excellence Award.

Each year a full independent financial audit is conducted by the firm of Marvin & Company. The Council/Board reviewed the independent audit, as well as the current financial reports, and reviewed the 990 tax filings. Members should know the Chapter maintains an active Budget and Finance Committee that oversees the budget and financial report and meets three times during the year. The Executive Committee reviews all financial summaries every other month. Tools to Help You and Your Patient Explore Out-of-Pocket Costs

Out-Pocket-Costs. Everybody is thinking about them, but we are not talking about them. Why? According to NYACP's June 2018 survey, the main barrier to cost conversations between patients and physicians is not knowing where to find cost information. In response, your Chapter has tools and resources to help you with more effective conversations about the cost of care.

It's important to remember that these conversations are not defined by providing out-of-pocket cost for a service. Although that information is ideal, it's not always feasible. What you can do is provide guidance, information and tools to help your patients estimate costs, <u>prevent surprise bills</u> and choose the best treatment for them. Simply letting patients know that you welcome the conversation is a great start!

When patients feel comfortable asking their physician about cost and quality, we learned that the 3 most frequent questions are related to medication costs, cost of services and where to go for treatment. Follow this link for tools that can be shared with your patients to assist them in getting answers to questions they may have. They can be shared with staff members who can help with cost conversations, such as nurses who assist with medication reconciliation and prior authorization personnel who assist with referral planning.

New York State Seeking Drug Utilization Review Board Membership



Federal legislation requires States to maintain a Drug Utilization Review (DUR) program and establish a Drug Utilization Review Board. The NYS Medicaid DUR Board provides recommendations to the Health Department associated with establishing clinical standards for Medicaid's pharmacy program. <u>The</u> <u>composition of the DUR Board can be found on pages 1</u> & 2 of the General Operating Procedures here.

Responsibilities of the DURB include:

• The establishment and implementation of medical standards and criteria for the retrospective and prospective DUR program.

- The development, selection, application, and assessment of educational interventions for physicians, pharmacists and recipients that improve care.
- The collaboration with managed care organizations to address drug utilization concerns and to implement consistent management strategies across the fee-forservice and managed care pharmacy benefits.
- The review of therapeutic classes subject to the Preferred Drug Program.
