NYS Department of Health Marijuana Program Information

The **Compassionate Care Act** that was signed into law on July 5, 2014 authorizes the Department of Health to implement a **Medical Marijuana Program in New York State**. Practitioners who wish to register with the Department and certify their patients for the Medical Marijuana Program must:

- Be qualified, by training or experience, to treat patients with one or more of the serious conditions eligible for medical marijuana;
- Be licensed, in good standing as a physician and practicing medicine, as defined in article one hundred thirty one of the Education Law, in New York State;
- Possess a Health Commerce System (HCS) Medical Professions Account user ID and password;
- Possess an active Drug Enforcement Administration (DEA) registration number; and
- Complete the four hour Department-approved medical use of marijuana course.

The 4-hour Department approved online course is not yet live, but will be available to practitioners within the next couple of weeks. The online course will be provided by [The Answer Page](#), an established online medical education provider. The course content was created by physicians with contributions from academicians and will be fully referenced. **The cost to take the course is \$249, and practitioners will earn 4.5 hours of CME credit upon successful completion.** The course will include the following topics:

- The pharmacology of marijuana;
- contraindications;
- side effects and adverse reactions;
- overdose prevention, drug interactions, dosing, abuse and dependence;
- routes of administration, risks and benefits;
- warnings and precautions.

Health Advisory: Influenza Surveillance and Reporting Requirements 2015-2016

The New York State Department of Health (NYSDOH) provides a document annually to summarize and assist healthcare providers, clinics, laboratories, local health departments (LHDs), hospitals, nursing homes, and others with influenza reporting requirements.

INFLUENZA SURVEILLANCE AND REPORTING REQUIREMENTS

NYSDOH will conduct enhanced influenza surveillance beginning the first week in October 2015 through the third week in May 2016 (the week ending October 10, 2015 through the week ending May 21, 2016). Reporting requirements vary by setting and provider type and are detailed below.

Healthcare Providers in the Ambulatory or Outpatient Setting

- Healthcare providers must report outbreaks of influenza or influenza-like illness (ILI) to the LHD of the county in which the outbreak is occurring. Contact information for LHDs can be found at <http://www.nysacho.org/i4a/pages/index.cfm?pageid=3713>.
- Healthcare providers are not required to report to NYSDOH positive influenza diagnostic tests performed outside of a full-service clinical laboratory (see Clinical Laboratory section).

ICD-10 Is Here! Make Sure Your Practice is Ready with These Great Resources

It's been several days since the implementation of ICD-10, and to ensure a smooth transition to the new coding system, here's a quick checklist of what should be done in this month:

- Make sure diagnosis is consistent with the procedure (age, gender, provider type, and so on).
- Be sure the code is valid? For Medicare FFS, it must at least be the right "family" - but for private payers and Medicaid, it needs to be as specific as possible. Use a book or electronic tool to confirm valid vs. invalid codes.
- Use the CMS [free look-up tool](#) and ACP's [downloadable "Commonly Used ICD-10-CM Codes" list](#).
- Keep medical necessity in mind. Does the code used support the CPT code? While this is nothing new, it is something to be hyper-vigilant about in the beginning.
- Be aware of referrals and authorizations that used ICD9 codes. Map back to ICD9 if necessary. Double check date of service and use correct code set.
- Track denials carefully - learn from mistakes and resubmit claims as soon as possible. Follow-up with payer as needed.
- Contact payer representatives for problem payers.

The impending mandate to electronically prescribe all prescriptions, including prescriptions for controlled substances, is rapidly approaching. Pri-Med Opioid Screening Online Course Now Available

With approximately 100 million adults in the U.S. suffering from chronic pain, the nonmedical use of prescription opioids has become a public health issue, and prompted the U.S. Food and Drug Administration to establish the Risk Evaluation and Mitigation Strategy (REMS) mandate. A total of 26 Continuing Medical Education (CME) and Continuing Education providers, including ACP, have created educational initiatives to help prescribers ensure that the benefits of a drug outweigh the risks for patients receiving extended release and long acting opioids.

ACP developed online training modules with Pri-Med to educate clinicians about best practices when prescribing opioids to patients and to help prescribers manage risk for abuse and inappropriate use. The REMS training modules provide comprehensive educational information for primary care clinicians, and can be completed for CME credit. [Access the online modules](#) for additional information.

Physician Quality Reporting System: 2016 Informal Review Process

In 2016, CMS will apply a negative payment adjustment to individual eligible professionals (EPs), Comprehensive Primary Care (CPC) practice sites, and group practices participating in the Physician Quality Reporting System (PQRS) group practice reporting option (GPRO) (including Accountable Care Organizations [ACOs]) that did not satisfactorily report PQRS in 2014. **Individuals and groups that receive the 2016 negative payment adjustment will not receive a 2014 PQRS incentive payment.**

If practice sites believe they have been incorrectly assessed the 2016 PQRS negative payment adjustment, they may submit an informal review between **September 9, 2015 and November 9, 2015** requesting CMS investigate incentive eligibility and/or payment adjustment determination. All informal review requestors will be contacted via email of a final decision by CMS within 90 days of the original request for an informal review. **All decisions will be final and there will be no further review or appeal.**

All informal review requests must be submitted electronically via the Quality Reporting Communication Support Page (CSP) which will be available through **November 9, 2015** under the Related Links section of the [Physician and Other Health Care Professionals Quality Reporting Portal](#).
