# Chapter Submits Written Testimony on Workforce Budget Proposals

Each year, the NYS legislature hosts joint public hearings to discuss the proposed Executive budget.

New this year was a joint hearing on workforce-related issues. NYACP submitted written testimony urging the Legislature to support the physician workforce programs, such as Doctors Across New York, as in the past.

In addition, we urged for a continued focus on new models to encourage and further build capacity in the primary care physician workforce to ensure access to health care for all residents.

## Extension of Certificate of Need (CON) to Physician Practices Under Consideration

A significant recommendation has been posed by the Public Health and Health Planning Council of the NYS Department of Health for consideration of the impact of many complex system changes that could result if CON requirements are imposed on single and multispecialty "mega" physician practices.

CON has previously only been required for Article 28 facilities including FQHCs and community health centers.
